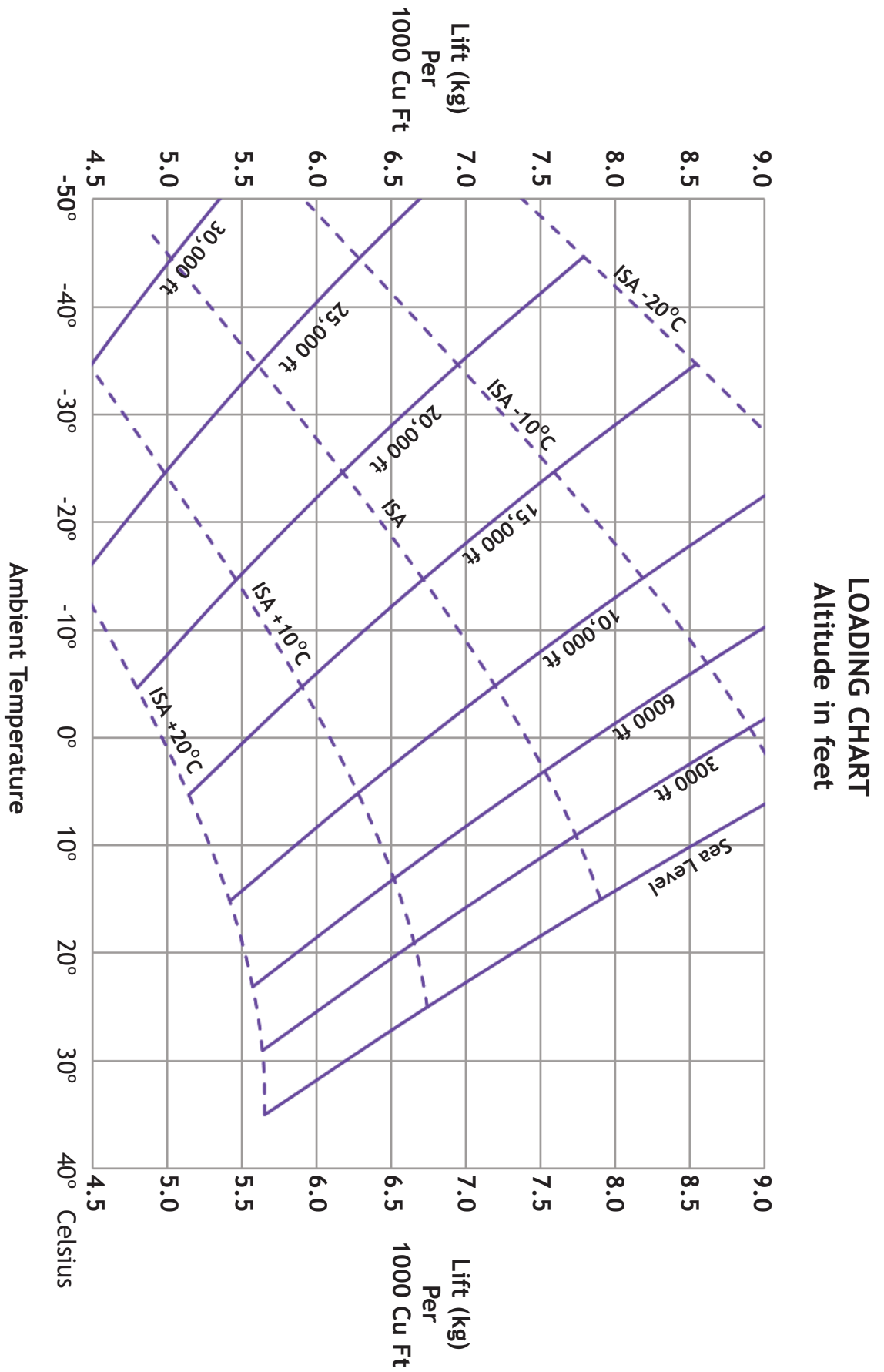

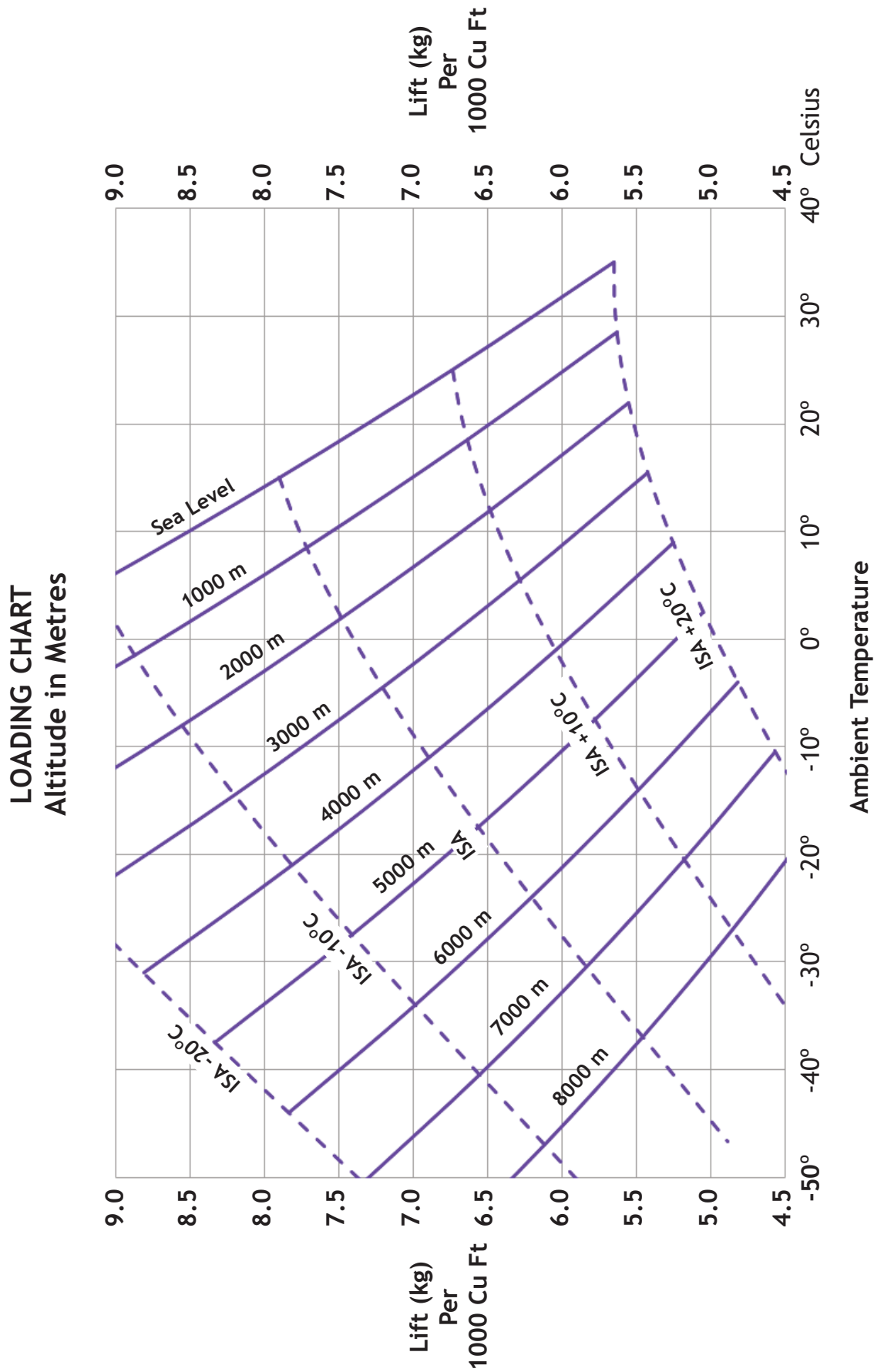
8.44.5 WEIGHT CALCULATIONS

8.44.5.1 INTRODUCTION

This supplement gives the required information to calculate the weight range within which the balloon can be operated when using metric (S.I.) units.

Cameron envelopes are defined by volume, measured in cubic feet. This supplement uses this convention and supplies the available lift in kilogrammes per 1000 cu.ft.
